Public Hearing called to order at 6:30 p.m.

Chairman Cox identified all the emergency exits within the building.

Chairman Cox made formal introductions of staff in attendance.

Chairman Cox introduced the Public Hearing regarding the 2024 Proposed Budget in accordance to New York State Town Law.

Our policy on Rules of Public Comment provides for the public to comment one-time for three minutes (a one-minute warning will be given) Questions will not be

answered at this time. You will be asked to state your name and address for the record. The public comment period will be after the Treasurer's presentation.

District Treasurer Brittany Gould facilitated a PowerPoint Presentation on the 2024 Proposed Budget.

Treasurer Brittany Gould reviewed the Mission Statement of The Gates Fire District.

The 2024 proposed budget is \$16,982,155 which consists of various appropriations offset by revenues from leases, interest and appropriations set aside from 2022 to be used to reduce the 2024 taxes.

The Gates Fire District operates in two municipalities, the Town of Chili and Town of Gates. The assessed value in total of these two municipalities is approximately \$2.8B. Town of Chili makes up about 17% of the Fire District tax levy and Town of Gates is about 83%.

The 2024 proposed budget and tax levy are increasing 6.7% and 3.3%, respectively, from 2023. The Gates Fire District exceeded the tax cap by only .3% or about \$49K.

Chairman Cox explained the purpose of this hearing is to allow any person to speak in favor of or against the proposed budget as compiled, or for or against any item or items therein contained.
