RFFTP (Recruit Firefighter Training Program) is in its final weeks, they are doing live fire training. Graduation will be held on Friday, June 16th at 10:00 am at the Wegmans Conference Center. The 33 mack will be located to the event for picture taking.

District inspection status-Station Inspections have been received. We are waiting on turnout gear inspections. Inspections should be available at the next commission meeting. They will be sent out electronically to the Commission.
