Future Apparatus/Reserve Funding

Revisited open budget lines

This year replacement 4C25 car, 4508 and rescue 4518 pursuant to Resolution 2021.12.20.2. Agree with the replacement of 4508, do not agree with the replacement of 4518 (has a little more than 17,500 miles on it and it is in rather good shape). 4C25 vehicle does not need to be replaced this year. There was a change with the succession

planning and we are going to be selling the 4C95 car, and instead of replacing the 4C25 car, would instead like to replace the 4557 car. 4557 car has been passed down several times and it is not best suited for the mechanic. Assistant Chief suggests to replace both pickup trucks 4508 and the 4557.

Reviewed some expenses for the apparatus to be expected.

Reviewed Apparatus replacement plan.

Airpacks will be hitting their end of life in 2030. Projected cost to replace is \$1,100,000.00.

Reviewed Capital Reserve account funding.

Reviewed Communications Reserve Account Funding.

Quote provided to repair 4530 from Churchville Fire Equipment at a cost of \$80,000.00. Commission discussed.

Commissioner Comenale noted concern for the safety of the members and has every confidence in the Chiefs and Mechanic in their recommendations.

Motion to approve Churchville Fire Equipment to repair 4530 at a cost not to exceed \$90,000.00 and authorize Assistant Chief to go ahead and move forward with pursuing the replacement made by Commissioner Werth and seconded by Commissioner Cox. Commission polled: All approved.
